- GST registration and PAN details.

- Any tender not accompanied by the CDR is liable to be rejected.
- All bids must clearly mention FOR IITM Srinagar and include all transportation and handling charges up to the institute premises.

- Incomplete bids or bids received after the deadline will be rejected.
- Installation and commissioning must be completed within 15 days of purchase order issuance.
- Payment terms will be as per institutional norms and mutually agreed upon.

### **OEM terms and conditions:**

- Non- Blacklist Certificate: The OEM bidder should not be blacklisted by any Govt. bodies
  in India. The bidder /OEM is required to submit an affidavit on a Non-Judiciary stamp as a
  proof.
- **Micro soft Certification:** The product should be certified by Microsoft to avoid any issues with future upgrades.
- **Online System Diagnostic Tool**: The OEM should provide online diagnostic tools for system diagnostics and ease of maintenance.
- **Verifiable System Configuration & Warranty**: The system configuration and variety should be verifiable on the OEM's website to confirm the authenticity of the supplied computers.
