- Involvement in social initiatives.

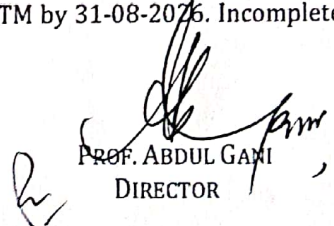
3. Documents Required
